- Good academic record with a Ph.D. Degree in the concerned / relevant disciplines.
- ii. A Master's Degree with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed).

- iii. - v. A minimum score as stipulated in the Academic Performance Indicator (API) based on ICAR Regulations / UGC Regulations.
- vi. The candidate should be the member of State Veterinary Council and Veterinary Council of India.

#### Qualifications:

- (1) A Master degree with atleast 55% of the marks OR its equivalent grade of B in the U.G.C. 7.0 point scale.
- (2) A Ph.D. in Agricultural sciences or equivalent qualifications
- (3) Atleast 15 years of experience as a Assistant Professor in the AGP of Rs. 7,000 and above OR with 8 years of service in AGP of Rs. 8,000 and above including as Associate Professor alongwith experience in educational and/ or administrative.

#### OR

Comparable experience in research/ establishment and / or other institutions of higher education.

#### OR

15 years of administrative experience, of which 8 years as shall be as Deputy Registrar.

#### OR

An officer holding equivalent post not below the rank of Joint Director of Agriculture OR Gujarat Administrative Service (Senior Scale) cadre.

**AGE**: A candidate shall not be more than 50 years of age.

Upper age limit may be relaxed upto 5 years in favour of a candidate who is already an employee in Agricultural Universities of Gujarat.

### Relaxation in qualifications:

1. A relaxation of 5% may be provided, from 55% to 50% of the marks to the Ph.D. Degree holders, who have obtained their Master's Degree prior to 19 September, 1991.

# Important:

- 1. New defined contributory pension scheme as introduced vide Government vernacular Resolution Dated: 18/3/2005 and 6/6/2005 No. NPN-2003-GOI-10-P will be applicable in case of candidates other than the employees of Agricultural Universities of Gujarat who have been appointed prior to the introduction of this scheme.
- 2. The post of SC, ST and SEBC will be filled up as per the State Government rules in all the posts.
- 3. Age relaxable in case of SC, ST and SEBC as per the State Government Rules.
- 4. Possess the basic knowledge of computer application as per Government of Gujarat rules. If the candidate without having passed CCC+ examination is selected, he / she will have to pass the said examination during the probation period, failing which, his / her services will be terminated.
- 5. The crucial date for determining the eligibility in respect of Age/ Educational Qualifications/Experience should be the closing date for receipt of application from candidates i.e. 21/07/2014.

Processing fee for general candidate is Rs.1000/- and Rs. 250/- for S.C. / S.T. / S.E.B.C. candidate of Gujarat State. The details of educational qualifications, experience, age etc. should be obtained from website www.jau.in.

An application in prescribed proforma, along with API score available on website, **www.jau.in** should be filled in completely and supported with attested copies of certificates of qualifications and experience.

The reservation of posts is for the <u>candidates of Gujarat State origin only</u>, therefore the candidates of other states need not apply for the reserved posts. In case of non-availability of women candidates, the post so reserved will be allotted to the male candidate of the same category. Relaxation up to five years in upper age limit shall be admissible for man candidates of the reserved categories and for women it will be ten years as per the criteria prescribed by Government of Gujarat State.

The SEBC candidate should furnish the current financial year's "Non Creamylayer Certificate" in the prescribed proforma along with the application form, failing which, the candidate will not be entitled to get the benefit of reserved category.

Application form duly filled in should reach the **Registrar**, **Junagadh Agricultural University**, **Junagadh** – **362 001** on or before closing date i.e., 21/07/2014.
