1. Candidate need to submit all the certificates in their serial numbers as appeared in the application form.
2. All the pages in the enclosures should be **self-attested and contain serial numbers** clearly visible at a uniform position preferable in the right hand side corner for the verification. Candidate should clearly mention the total number of the pages attached in the application.
3. Surname must be filled in the block provided for the Last Name, Father's name or any of the middle names if given in the SSC certificate must be filled in the Middle Name and candidates own name must be filled in the first name. (e.g., if the full name of the candidate is HIREN BHUPATBHAI META, He should write "HIREN" as First Name {Own name}; "BHUPATBHAI" as Middle Name {Father's Name} and "META" as Last Name {Surname}.
