Relaxation in qualifications for teaching Posts :

1. For the purpose of eligibility and for assessing good academic record during direct recruitment, a relaxation of 5% at the graduate and master's level for the Scheduled Caste / Scheduled Tribe / Differently-abled (Physically and visually differently-abled) categories of the candidates. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based on only the qualifying marks excluding grace marks if any.

Surname must be filled in the block provided for the Last Name, Father's name or any of the middle names if given in the SSC certificate must be filled in the Middle Name and candidates own name must be filled in the first name. (e.g., if the full name of the candidate is HIREN BHUPATBHAI META, He should write "META" as Last Name {Surname}; "BHUPATBHAI" as Middle Name {Father's Name} and "HIREN" as First Name{Own name}
4. Candidate belonging to the specific category need to submit the attested copy of the "Category Certificate" duly signed by the competent authority.
