If the candidate without having passed CCC+ examination is selected, he / she will have to pass the said examination during the probation period, failing which, his / her probation period will not be regularized.

Relaxation in qualifications for teaching Posts:

- 1. For the purpose of eligibility and for assessing good academic record during direct recruitment, a relaxation of 5% at the graduate and master's level for the Scheduled Caste / Scheduled Tribe / Differently-abled (Physically and visually differently-abled) categories of the candidates. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based on only the qualifying marks excluding grace marks if any.
- A relaxation of 5% may be provided, from 55% to 50% of the marks to the Ph.D. Degree holders, who have obtained their Master's Degree prior to 19 September, 1991.

General Instructions:

1. Processing fee for general candidate is Rs.1000/- and Rs. 250/- for S.C. / S.T. / S.E.B.C. / P.H. candidates of Gujarat State. The details of educational qualifications, experience, age etc. should be obtained from website www.jau.in The application should be submitted online from website http://jau.ojas.sauguj.in after paying the processing fee through internet banking through the website http://www.onlinesbi.com. The candidate can also pay the processing fee in cash by downloading the "State Bank Collect" challan from http://www.onlinesbi.com

After Paying the processing fee, the form can be filled up online next working day after 14:00 Hrs.

- 2. The hard copy of the application supported with attested copies of certificates, pertaining to the qualifications, API and experience should reach to the Registrar, Junagadh Agricultural University, Junagadh before Dt.10/03/2016. The University reserves its right not to fill-in all or any post if deems necessary.
- 3. The reservation of posts is for the <u>candidates of Gujarat State origin only</u>, therefore the candidates of other states need not apply for the reserved <u>posts</u>. In case of non-availability of women candidates, the post so reserved will be allotted to the male candidate of the same category. Relaxation up to five years in upper age limit shall be admissible for man candidates of the reserved categories and for women and physically handicapped, it will be ten years as per the criteria prescribed by Government of Gujarat State.
- 4. The SEBC candidate should furnish the current financial year's "Non Creamylayer Certificate" in the prescribed proforma along with the application form, failing which, the candidate will not be entitled to get the benefit of reserved category.
- 5. Candidates should submit online the Soft copy of completed application as well as signed hard copy (print out) of same with necessary documents. Attested certified true copies of the certificates/documents should be attached with application form.
- 6. Application with demand draft and copies of testimonials should be sent in a cover superscribing "Application for the post of" should reach the undersigned on or before last date prescribed.
- 7. Candidate must submit the filled in API Form in hard copy along with copy of research papers / books / articles / certificates etc., (put serial number on each attachment in ascending order).
- 8. Application incomplete in any respect, applications without required supporting documents or those received after the last date of receipt of application will not be considered.
- 9. Relevant experience and educational qualifications of candidates will be counted as on the last date of submission of online application i.e. Dt.05/03/2016 Accordingly, the candidates should confirm their eligibility for the post applied for, before the submission of application. No separate correspondence whatsoever in this regard shall be entertained by the University.
