Annexure-I

Ammendment of the Statute-115 (Rule No.22) State Agricultural Universities Services of Gujarat [Recruitment & Career Advancement Schemes (CAS) of Teachers] Rules, 2011

Rule-22(A)

- (a) The Selection Committee for Direct Recruitment of Principal shall have the follwing composition:
 - 1. The Vice Chancellor as Chairman
 - 2. An academician who is the nominee of the Chancellor.
 - One member of the Board of Management to be nominated by the Vice Chancellor.
 - Two Vice Chancellor's nominees out of whom one should be an expert in academic administration.
 - Three experts consisting of the Principal of a college, a Professor and an accomplished educationist not below the rank of a Professor, to be nominated by the Vice Chancellor out of a panel of experts approved by the Board of Management.
 - 6. An academician representing SC/ST/OBC/ Minority/ Women/ Differently-abled categories, if any of candidates representing these categories is the applicant, to be nominated by the Vice Chancellor, if any of the above members of the selection committee do not belong to that category.
- (b) At least four members, including two experts shall constitute the quorum.
