9. <u>Completeness of Tender Offer</u>

i. - iv. Tender document not accompanied by all the Technical/ Preliminary Bid related Schedules/Annexures intact and duly filled in and signed shall be rejected.
- v. The Tendering Authority shall not be liable for any omission, mistake or error on the part of the Tenderer in submitting the Tender.
- vi. The Tenderer shall not incorporate any condition in the Bids as conditional Bids/ Bids which are not submitted strictly in accordance with the Bid terms shall be rejected.

10. Documents Comprising the Tender

The tender shall comprise of Technical/Preliminary Bid and Commercial Bid and all its Annexures and all supporting documents and attachments. The Bids complete in all respect including all attachments, annexures and supporting documents as prescribed in this Tender Document shall be uploaded by the authorized signatory as stipulated in the Tender. 11. <u>Submission of Bids</u>

Tender shall submit the complete Bid including Technical/Preliminary and Commercial Bid on https://www.nprocure.com within the stipulated date & time and no opportunity shall be given to Tenderer to withdraw any offer at any stage after the submission of the Bids.

The Technical/Preliminary Bid shall include the following:

- ii. - iii. Self-attested Scanned copies of Authority of Authorized Signatory/ Power of Attorney/Partnership deed/Memorandum of Association/Articles of Association/ Authority of BOD of a Company, Experience certificates, PAN Card & GST Registration Certificate etc. as the case may be and as stipulated in the Tender document.
- iv. - ii. The rates quoted by Tenderer shall be applicable & firm throughout the period of the contract.
- iii. It should give all relevant price information and should not contradict the Technical/ Preliminary Offer in any manner.
- iv. The prices quoted in the commercial bid should be without any conditions.

- v. Tenderer should quote all-inclusive Price inclusive of Supply, Installation, commissioning, Transportation, Forwarding, Insurance, Training, Warranty, all types of Taxes including GST, etc.
- vi. The commercial offer shall be on a fixed price basis. No price variation should be asked for relating to increase in dollar price variation.
- vii. Prices quoted will be firm for the entire period of Contract. All prices to be quoted in Indian Rupees.
- viii. It is the responsibility of the Bidder to clearly identify all costs associated with any item or series of items in this Tender. The Bidder must include and complete all parts of the cost Proposal in a clear and accurate manner. Omissions, errors, misrepresentations, or in adequate details in the Bidder's cost proposal will be considered as valid ground for rejection of the Vendor's proposal. Costs that are not clearly identified will be borne by the Bidder.

12. The EMD submitted by the bidder will be forfeited if:

- i. The Bidder withdraws his tender before processing of the same.
- ii. The Bidder withdraws his tender after processing but before acceptance of "Work Order/Purchase Order" issued by Tendering Authority.
- iii. If Bidder does not respond to requests for clarification of their Bid.
- iv. If Bidder fails to co-operate in the Bid evaluation process, and
- v. In case of a successful Bidder, if the Bidder fails:
 - a) To sign the Contract as mentioned above within the time limit stipulated by purchaser or
 - b) To furnish performance bank guarantee (Security Deposit) within stipulated time or
 - c) If the successful bidder is found to be involved in fraudulent practices or
 - d) The selected bidder withdraws his tender before furnishing an unconditional and irrevocable Performance Bank Guarantee or
 - e) If the bidder fails to submit the copy of purchase order & acceptance thereof.
 - f) The bidder violates any of the provisions of the terms and conditions of this tender specification.

13. <u>The EMD will be refunded to:</u>

- i. The successful bidder, only after furnishing an unconditional and irrevocable Performance Bank Guarantee for 5% of the contract value.
- ii. The unsuccessful bidders, only after acceptance of the "Work Order/Purchase Order" by the selected bidder.

14. <u>Preliminary Scrutiny</u>

- Prior to the detailed evaluation, the Purchaser will determine the substantial responsiveness of each offer to the tender document. For purpose to these clauses, a substantially responsive bid is one which confirms to all the terms and conditions of the Tender Document without material deviations. The purchaser's determination of offer's responsiveness is to be based on the contents of the Tender Offer itself without recourses to extrinsic evidence.
- The Purchaser will scrutinize the offer to determine whether the offer is complete, whether required technical documentation have been furnished, whether the documents have been properly signed, and whether the offer is in order.
- A tender offer determined as not substantially responsive will be rejected by the purchaser and the commercial bid for such Tenderer will not be opened.
- The Purchase may waive any minor infirmity or irregularity in a Tender offer, which does not constitute a material deviation. This shall be binding on all Tenderers and the Purchaser reserves the right of such waivers.

15. Opening and Evaluation of Technical/Preliminary Bid

The Technical/Preliminary Bids will be opened online at Information Technology Cell, Junagadh Agricultural University, Junagadh as per schedule indicated in the Tender and evaluated by committee as per the Tender terms & Conditions and Instructions. The Tenderer will be at liberty to be present either in person or through an authorized representative at the time of opening of the Technical/Preliminary Bid.

To assist in the scrutiny, evaluation and comparison of offer, the Purchaser may, at its discretion, ask some or all Tenderers for technical clarification of their offer. The request for such clarification and the response shall be in writing. To speed up the response process, the Purchaser, at its discretion, may ask for any technical clarification to be submitted by means of facsimile by the Tenderer. In such cases, original copy of the document describing the technical clarification must be sent to the Purchaser by means of e-mail within intimated time. The Purchaser will short list Technically/Preliminary qualifying Tenderers and Commercial offers of only these Tenderers will be opened.

16. Opening and Evaluation of Commercial Bid

Commercial Bids of only Technically/Preliminary qualified Tenderer (s) will be opened at Information Technology Cell, Junagadh Agricultural University, Junagadh as per schedule indicated in the Tender and evaluated as per the Tender terms & Conditions and Instructions. The Technically/Preliminary qualified Tenderer will be at liberty to be present either in person or through an authorized representative at the time of opening of the Commercial Bids. The Tender Item wise lowest Commercial Bid (L-1) shall be determined after confirming whether the Price Bids are complete and without errors.

After opening of the commercial offers of the short-listed Tenderers, if there is a discrepancy between words and figures, the amount indicated in words will prevail.

Scheduled date for opening Commercial Bid may be extended in unavoidable circumstances. In such case, revised date for opening Commercial Bid will be intimated to all Technically/ Preliminary qualified Tenderer via e-mail.

17. Award Criteria

- Contract will be awarded to the Technically/Preliminary Qualified Tenderer whose Commercial Offer has been determined to be item wised lowest evaluated offer with the right of Tendering Authority to negotiate still for a better price. The Commercial Offer will be considered based on tender item wise lowest cost. Contract may be awarded even if only one bidder qualifies Technical/Preliminary and Commercial offer. However, Tendering Authority reserves the right to take appropriate decisions in such case which shall be final.
- Contract will be awarded for 3 (Three) years/ 36 (Thirty Six) Months on Annual Renewal Basis subject to Satisfactory Performance for **Tender item 1, 2 and 3**. Contract will be awarded for 1(One) year/12 (Twelve) Months for **Tender item 4, 5 and 6**.

18. <u>Authorized Signatory</u>

b. Penalties for Delay in Commissioning

The schedule to be given for testing and acceptance and/or delivery and installation at site is to be strictly adhered to, in view of the strict time schedule for implementation of various projects of the Tendering Authority as time is essence of the contract.
