## 5. Guidelines and Terms & Conditions

### 5.1 Cost of bidding

The bidder shall be solely liable to bear all costs and expenses associated with the preparation and submission of its bid, and Junagadh Agricultural University will in no case be held responsible or liable for payment of any costs associated with the preparation or submission of the said bids irrespective of the outcome of the bidding process and also in cases where the entire bidding process or part thereof is nullified/ cancelled due to any reason whatsoever.

### 5.2 Two bid system

Two separate Bids (one Cover for tender fee & EMD, Second cover for Technical Bid) Commercial Bid must be submitted online at <https://nprocure.com> by the date and time prescribed in the tender notice.

#### 5.2.1 Technical bid

#### 5.2.2 Price-bid

Price Bid to be submitted on line on [www.nprocure.com](http://www.nprocure.com) website in a prescribed format as mentioned in tender before the stipulated date and time.

#### **For Internet Bandwidth:**

The bidder shall tie up with an ISP for provision of internet bandwidth and Operation and Maintenance of Project for 1 year as per terms and condition laid down by Junagadh Agricultural University under this tender. The bidder should submit a duly notarized copy of signed MOU between him and ISP clearly indicating specific roles and responsibilities of both parties specific to this tender. Bidder should also ensure that the ISP satisfy all the eligibility criteria set for ISP as mentioned in eligibility criteria section.

### 5.3 Award of Contract

Junagadh Agricultural University will award Contract to Technically Qualified and on the basis of L1 of Total Projected Cost.

### 5.4 Cost of the Tender Document

The bidder shall be submitted of tender document cost of Rs.1500 (Fifteen Hundred Only) by Demand Draft (DD) / Pay Order in favour of Junagadh Agricultural University Fund A/C, Payable at Junagadh.



### **5.5 Earnest Money Deposit (EMD)**

The bidders must submit, along with their Bids, an EMD of Rupees One Lakh Only (Rs. 1,00,000) or 3 % of total quoted tender amount whichever is less, in the form of FDR / Pay Order (PO) in favour of “Junagadh Agricultural University Fund A/c” Payable at Junagadh.

#### **Forfeiture of earnest money:**

The earnest money will be forfeited in the following cases:

1	Withdraws his bid during the period of bid validity specified by the Bidder on the Bid.
2	In case of the successful Bidder, if the Bidder fails to sign the Contract or furnish performance bank guarantee.
3	When the Bidder does not deposit the security money after the supply order is given.
4	When bidders fail to commence the requirements as per Purchase order within the time prescribed.
5	Bidder does not accept the purchase order.

### **5.6 Due Diligence**

The Bidder is expected to and shall be deemed to have examined all instructions, forms, terms and specifications and other information in this Tender Document. The bid should be precise, complete and in the prescribed format as per the requirement of the Tender Document. Failure to furnish all information required by the Tender Document or submission of a bid not responsive to the Tender Document in every respect will be at the Bidder’s risk and may result in rejection of the bid.

### **5.7 Language of Bid**

All Proposals and various documents related to these Proposals should be in English Language. All correspondence between Junagadh Agricultural University and the Bidders would also be in English Language. Supporting Documents and Printed Literature furnished by the Bidders may be in another Language provided they are accompanied by an accurate translation in English Language.

### **5.8 Fixed Price**

The Commercial bid shall be on a fixed price basis, inclusive of all taxes, duties and levies for the period of One year. Any statutory change in the taxes and levies subsequent to offer during contract period shall be borne (paid in case of increase / credited in case of decrease) by JUNAGADH AGRICULTURAL UNIVERSITY.

- B. As per above table JAU requires Connectivity Solution Network between JAU and rest 10 University locations.
- C. The offered solution must be highly secure.
- D. For all above locations last mile should be either RF OR OFC.
- E. Necessary university approval to take OFC cable till server room and radio mounting shall be provided by JAU.
- F. During the execution of the contract, the JUNAGADH AGRICULTURAL UNIVERSITY reserves the right to Up-grade the bandwidth as per the requirement in future. The additional charge will be applicable on prorata basis of the cost of the bandwidth provided vide the purchase order with the terms and conditions of the original contract.
- G. Operation and Maintenance of all the Supplied Device should be provided by ISP partner for a period of 1 year.
- H. ISP have to sign a Service Level Agreement (SLA) with JUNAGADH AGRICULTURAL UNIVERSITY to provide uninterrupted Service and maintenance support of entire solution for a period of 1 year.
- I. Performance guarantee tests are to be carried out on completion of integration and submission of reports. All tests carried out, are to be materialized and to be submitted in two copies. It should include the bandwidth test, data redundancy, network latency, data packet loss and other test suggested by JUNAGADH AGRICULTURAL UNIVERSITY considering requirement.
- J. Bidder has to arrange voltage stabilizer devices to secure their routing device due to major voltage fluctuation observed. JAU will be not responsible for damage of these routing devices.

### **5.13 Technical Inspection and Performance Evaluation**

JUNAGADH AGRICULTURAL UNIVERSITY reserves its right to carry out performance evaluation (benchmarking) of equipment's offered by technically qualified bidders and a technical inspection after commissioning.

## 5.14 Penalty & SLA

If Agreed SLA not met by the Bidder Junagadh Agricultural University will Deduct Payment as per uptime SLA Terms from Bidders Invoice.

## 5.15 Evaluation of Bids

Evaluation of Bids will be in two stages as under:

### 1. Eligibility Evaluation

JUNAGADH AGRICULTURAL UNIVERSITY will first scrutinize Tender Fee & EMD and then the eligibility of the bidders as per “eligibility criteria” & “Technical Specifications” The bidders who fulfil the above eligibility criteria will be taken up for further. The JUNAGADH AGRICULTURAL UNIVERSITY reserves its right to reject any or all tenders.

### 2. Commercial Evaluation

JUNAGADH AGRICULTURAL UNIVERSITY will open and scrutinize the commercial offers of the eligibility qualified bidders only. The Commercial bids will have to be submitted online. The calculation arrived by JUNAGADH AGRICULTURAL UNIVERSITY will be final and will be binding on the bidders. If any cost item in the commercial bid is found to be blank and not filled with any amount then it shall be considered as zero cost items and the same is offered to the JUNAGADH AGRICULTURAL UNIVERSITY free of any charge. JUNAGADH AGRICULTURAL UNIVERSITY will consider the cost for One year with all taxes for the purpose of price comparisons given by the vendors on the figures in commercial offer. Offer will be awarded on the basis of L1 of total project cost. Total cost will include cost of one time setup and services. The JUNAGADH AGRICULTURAL UNIVERSITY reserves its right to reject any or all tenders without assigning any reason thereof.

## 5.16 Negotiation

It is absolutely essential for the bidders to quote the lowest price at the time of making the offer in their own interest. JUNAGADH AGRICULTURAL UNIVERSITY, however, will have the discretion to choose to enter into any price negotiations or not.

### 5.17 Installation and Commissioning Period

Successful bidder has to commissioned total solution within 30 days from the date of LOI or purchase order which is earlier.

### 5.18 Payment Terms

### 5.19 Performance Measurement

Problem resolution time for the complaint due to RF, Internet malfunctioning including wiring issues will be 4 hours excluding complaint day. If the Service is not made up within 48 hours, the RF Device should be replaced.

### 5.20 Liquidated Damages

If the registered call is not solved/ repaired/replaced/temporary replacement within 24 hours excluding complaint day then 1% of Services cost as penalty per call per week.

### Late Commissioning Liquid Damages

If successful bidder fails to commission within 30 days from the date of letter of intent / work order, JUNAGADH AGRICULTURAL UNIVERSITY will impose the penalty 1% of cost.

### 5.21 Termination

JUNAGADH AGRICULTURAL UNIVERSITY reserves its right to terminate the order without assigning any reasons with 30 days' notice period.

### 5.22 Dispute Resolution and Jurisdiction

The Parties shall endeavour, in the first instance, to resolve any dispute, disagreement or difference arising out of or in connection with this Agreement, including any question regarding its interpretation, performance, existence, validity, termination and the rights and liabilities of the Parties to this Agreement (a "Dispute") through good faith negotiations.

"Matter relating to any dispute or difference arising out of this Tender and subsequent contract shall be subject to the exclusive jurisdiction of Courts at Junagadh only"

"All questions, disputes, differences and/or interpretation of agreement whatsoever, which may at any time arise between the parties to this contract in connection with the contract or any matter arising out of or in relation thereto, shall be referred to Sole Arbitrator as per the provisions of Arbitration and Reconciliation Act, 1996 if the said disputes are not resolved amicably through negotiation and the venue of arbitration proceedings shall be at Junagadh. The Language of the Arbitration shall be in English."

### **5.23 Force Majeure**

If bidder is prevented from performing any of its obligations under the Contract due to any cause beyond the bidder's reasonable control-if the bidder's performance is prevented by a superior brute force,- including, without limitation, an act of God like fire, flood, explosion, earthquake, war, strike, embargo, government regulation, civil or military authority, etc., the time for that bidder's performance will be extended for the period of the delay or inability to perform due to such occurrence; provided however, that if a bidder suffering a force majeure event is unable to cure that event within a mutually agreed duration, the buyer may terminate the contract.

Force majeure does not include bidder's organizational issues, bankruptcy, merger and acquisition issues, solvency, etc.

Force majeure event once faced shall be immediately informed to the buyer with the details of event, its likely effect on the contract, etc. Such information should reach to the buyer within a period of 15 days from the time of occurrence of the event.

If the performance in whole or part of any obligation under this contract is prevented or delayed by reasons of any such event for a period exceeding 60 days, buyer may at its option terminate the contract provided also that if the contract is terminated under this clause, the Buyer shall be at liberty to take over from the Contractor at a price to be fixed by the Buyer, which shall be final, all acceptable deliverables in the possession of the Contractor at the time of such termination or such portion thereof as the Buyer may deem fit accepting such deliverables.
