Terms & Conditions for Tender Set - I (Common Antibiotics)

- 1. Tender fee of Rs. 1500/- (Non Refundable) must be provided through DD in favour of "Junagadh Agricultural University Fund A/C".
- The EMD (Earnest money deposition) for an amount 15000/- per set of item to be paid in form of F.D.R. only, from any nationalized bank of India, drawn in favour of JAU fund A/C payable at Junagadh.
- 3. Quotation without tender fee and EMD will not be considered.
- In case of unsuccessful tenderer, the EMD shall be released after finalization of the tender, while in case of successful tenderer, the EMD shall be released after successful completion of the tender period.
- 5. Rates quoted should be inclusive of all applicable Taxes, Vat, GST and Discount with F.O.R. to our Department/ Laboratories/College at J. A. U., Junagadh.
- 6. It is mandatory to submit your final rates only in the given format along with the tender forms and duly signed on each pages by the authorised person.
- 7. Tenderer has to sign on all the pages of quoted prices as well as in terms and conditions.
- They have to supply long duration of expiry dates (minimum two years from date of supply). If expiry date comes within three months before the end of validity date of these tender (i.e. 31-03-2019) materials should be replaced/exchanged in time and with same quantities with longer period of expiry.
- 9. The manufacturers shall have to stick to quality standards as asked for, while supplying the goods. The lowest price is not the criteria and emphasis is given to specifications and quality of goods. The JAU has right to reject any or all the offers and invite fresh quotations, if need arise. The JAU further reserves the right of selecting the brand and accepting or otherwise any of the conditions stipulated by the tenderer.
- 10. The supply must be within delivery period mentioned in the order otherwise the consignment will be rejected.
- 11. For all legal purpose court jurisdiction will be Junagadh, Gujarat. Terms and conditions of English version will be valid.
- 12. Validity of the quotation should be up to **31.03.2019**.
- 13. In case of defective items, the same shall have to be replaced by the party concerned at its own cost, and risk and within stipulated time. If in any case, the quoted item is not available in the market, the successful bidder will have to supply higher version/ replacement of that item in the quoted cost in the same time duration with prior approval of competent authority.
